### NOTICE REGARDING YOUR RESIDENCE ADDRESS

Michigan law requires that the same address be used for voter registration and driver license purposes. Therefore, if the residence address you provide on this form differs from the address shown on a driver license or personal identification card issued by the State of Michigan, the Secretary of State will automatically change your driver license or personal identification card address to match the residence address entered on this form. If an address change is made, the Secretary of State will mail you an address update sticker for your driver license or personal identification card.

# Affidavit of Voter Registration

**Important:** The use of this form is restricted as explained below. Read carefully before completing. Falsifying the form is a violation of Michigan election law punishable by a fine of up to \$1,000.00 and/or imprisonment for up to 5 years.

**Restrictions on use of affidavit:** A voter whose name does not appear on the precinct's Qualified Voter File (QVF) registration list can vote by executing this affidavit if **both** of the following criteria apply. If both of the following criteria do not apply, the submission of this form to obtain a ballot is illegal. Criteria:

- 1.) The voter must have submitted a voter registration application through a Secretary of State branch office, a designated voter registration agency, the county clerk, or the mail **before** the registration deadline for the election at hand. (The registration deadline elapses 30 days before the election. If the registration deadline falls on a Saturday, Sunday or legal holiday, it is moved to the next business day.)
- 2.) The voter must not have voted in any previous elections held in the city or township since registering to vote. (If a voter whose name does not appear on the precinct's QVF registration list indicates that he/she has previously voted in the city or township, contact the clerk as further inquiry into the voter's registration status is needed.)

**Procedure if voter is eligible to use affidavit:** If the voter meets the two criteria detailed above, the voter can obtain a ballot through the submission of this form. As a part of the procedure, the voter must (1) complete the affidavit on the opposite side under oath (2) provide proof of identification sufficient to satisfy the clerk or an authorized assistant appointed by the clerk as to his/her identity and residence and (3) complete the voter registration application on the opposite side. A voter issued a ballot under the affidavit procedure must vote a "challenged" ballot.
