**430.01 PARKING OF COMMERCIAL VEHICLES OR TRAILERS IN RESIDENTIAL DISTRICTS PROHIBITED; EXCEPTIONS.**

(a) Definitions. As used in this chapter:

- (1) "Commercial vehicle" means all motor vehicles used for the transportation of passengers for hire, goods, wares or merchandise, weighing two and one-half tons or more, without load, or being more than twenty-two feet in overall length or having more than two axles.
- (2) "Restricted area" means all areas of the City of Litchfield which are defined in the Zoning Code as "R-1" and "R-2" Residential Districts.
- (3) "Street" means the paved or traveled portion of the road right-of-way.
- (4) "Trailer" means all vehicles, being more than sixteen feet in overall length, designed for carrying property or persons and for being drawn by a motor vehicle.

(b) Restricted Commercial Parking. No person shall park a commercial vehicle or trailer on the streets of the restricted area of the City of Litchfield as defined in subsection (a) hereof.

(c) Exceptions. The provisions of this section shall not apply to commercial vehicles or trailers parked while making actual deliveries or while engaged in construction, general repair, furniture moving or other type of commercial work.

**430.02 OVERNIGHT PARKING PROHIBITED; EXCEPTIONS.**

(a) No person shall park any vehicle, trailer or other object on any of the streets of the City between the hours of 2:00 a.m. and 6:00 a.m. on each day of the week.

(b) The provisions of this section shall not apply to commercial vehicles parked while actually making deliveries or while engaged in and necessary to construction, general repair or other types of commercial activity occurring upon said streets within the City of Litchfield.

**430.03 PARKING IN CONFORMITY WITH SIGNS.**

No person shall stop, stand or park a vehicle, except when necessary to avoid conflict with other traffic or to comply with the provisions of this Traffic Code, or while obeying the directions of a police officer or a traffic control device, at any place where signs prohibit stopping, standing or parking, or where the curbing is painted yellow, or at any place in excess of the maximum time limited by signs.

**430.99 PENALTY.**

Whoever violates or fails to comply with any of the provisions of this chapter is responsible for a civil infraction and shall be subject to the provisions of Section 202.99 of the Administration Code.
