Treasurer Barrett handed out a copy of the Economic Vitality Incentive Program report to the board members and stated that the state puts out and is part of revenue sharing. Now she is required to provide certain reports and make them available on line to the public in order for the city to receive that portion of the revenue sharing. This report that was just given to the board tonight are based off the audit or F65 reports and are due a month earlier than the F65 report, so these reports weren't done on time because she didn't have the audit or F65 reports done to base it off of, so now that the F65 is done she is working on completely the other reports. The city will miss a small amount of revenue sharing for the first quarter but will receive the following quarter.

Treasurer Barrett stated she will more than likely bring some budget amendments to the at the next meeting it is only required to be done once a year but doing amendments more than once a year demonstrates the city is being fiscally responsible.

City Manager's Update – Manager Terry informed the board that the he has started putting together bid specifications for Warner Avenue and Park Street for milling and paving. Also, he has been working on possible water main replacement on Mill Street and Southfield Street.
