**Consent Agenda** — Councilman Siebert moved to approve the consent agenda as presented, seconded by Councilwoman Bills. Motion carried.

Sewer Credit Request – Mobile Home Park –Clerk, Ballinger explained to the board that the park had an underground water line break and it took approximately three weeks for the owner to find due to the extra dry condition of the ground. Councilman, Bannick moved to approve a sewer credit for 309 W. Saint Joe Street in the amount of \$465.81, seconded by Councilman, Smith. Motion Carried.
