ORDINANCE NO. 2020-01

AN ORDINANCE TO APPROVE THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AND RESOLUTIONS AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF LITCHFIELD, MICHIGAN, AND TO REPEAL ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH.

WHEREAS, various ordinances and resolutions of a general and permanent nature have been passed since the date of the last updating and revision of the Codified Ordinances of Litchfield, Michigan (June 30, 2016), and have been included in said Codified Ordinances; and

WHEREAS, in the course of preparing the 2020 Replacement Pages for the Codified Ordinances it was found necessary to make substantive changes in certain sections in the Codified Ordinances and said new matter should be approved, adopted and enacted; now, therefore:

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the City Council of Litchfield, Michigan as follows:

Section 1. That the editing, arrangement and numbering or renumbering of the following ordinances and resolutions and parts of ordinances and resolutions are hereby approved as parts of the various component codes of the Codified Ordinances of Litchfield, Michigan, so as to conform to the classification and numbering system of the Codified Ordinances, to wit:


Section 2. That all ordinances and resolutions or parts thereof enacted prior to June 30, 2016, which are inconsistent with any provision of the new matter adopted in Section 1 of this ordinance, are hereby repealed as of the effective date of this ordinance, except as follows:


The enactment of such new matter shall not be construed to affect a right or liability accrued or incurred under any legislative provision prior to the effective date of such enactment, or an action or proceeding for the enforcement of such right or liability. Such enactment shall not be construed to relieve any person from punishment for an act committed in the violation of any such legislative provision, nor to affect an indictment or prosecution therefor. For such purposes, any such legislative provision shall continue in full force notwithstanding its repeal for the purpose of revision and recodification.

Section 3. That this ordinance shall be published pursuant to Section 5.4 of the City Charter.

Section 4. That this ordinance and the 2020 Replacement Pages of the Codified Ordinances hereby approved, adopted and enacted shall go into effect thirty (30) days after adoption by city council.

This ordinance was duly adopted by the City Council for the City of Litchfield during a Regular Meeting held the 21 day of April, 2020.
